The License holder, their employees or their bona fide volunteers must conduct all sales, furnishing, tendering, and serving at the event.

^{*}Third party organizers or Party Planners may not be compensated to operate or manage the event. Caterers may provide food services only, but may not purchase, sell, or serve wine or nonintoxicating beer. The Licensee holder, their employees or their bona fide volunteers must conduct all sales, furnishing, tendering, and serving at the event.

^{**}Charitable auctions of sealed bottles of wine and/or beer for off-premises consumption are permissible if the organization obtains an appropriate license.
