# INSTRUCTIONS FOR COMPLETING APPLICATION FOR RETAIL CLASS A LICENSE-ON PREMISES PRIVATE FOOD TRUCK /PRIVATE CIGAR SHOP/PRIVATE BAKERY /PRIVATE FARMERS MARKET

### Requirements ---- Private Food Truck- \$2,150.00, plus \$100.00 operational fee

- Has at least 10 members.
- Operates a Private Food Truck which includes:
  - O A two-burner hot plate, air fryer, or microwave oven;
  - o A sink with hot and cold running water;
  - At least a 10 cubic foot refrigerator or freezer, or some combination of a refrigerator and freezer which is not used for alcohol cold storage; and
  - o Plastic or metal kitchen utensils and other food consumption apparatus as determined by the commissioner.
- Maintains, at any one time, \$200 of food inventory that is fit for human consumption and capable of being prepared and served from the private food truck's kitchen during all hours of operation.
- Shall be sponsored, endorsed, or approved by the governing body or its designee of the county or municipality in which the private food truck is to be located and operate, and further each location shall have a bounded and defined area and set hours for private food truck operations, sales, and consumption of alcohol that are not greater than a private club's hours of operation.
- Provides the commissioner with a list of all locations, including a main business location, where the private food truck operates, and is approved for sales and immediately update the commissioner when new locations are approved by a county or municipality.
- All nonintoxicating beer and nonintoxicating craft beer sold, furnished, tendered, or served is to be purchased from the licensed distributor where the private food truck has its home location or from a resident brewer acting in a limited capacity as a distributor
- Wine or hard cider sold, furnished, tendered, or served pursuant to the license is to be purchased from a licensed distributor, winery, or farm winery in accordance with §60-8-1 et seq. of this code.
- Liquor sold, furnished, tendered, or served shall be purchased from a licensed retail liquor outlet in the market zone or contiguous market zone where the private food truck has its main business location.
- Uses an age verification system approved by the commissioner for the purpose of verifying that persons under the age of 21
  who are in the private food truck's locations are not permitted to be served any alcoholic liquors, nonintoxicating beer or
  nonintoxicating craft beer, or wine but may be permitted to purchase food or other items.
- A Private Manufacturer Club may also apply for a Private Food Truck license.
- Meets and is subject to all other applicable private club requirements.

### Requirements----Private Cigar Shop - \$1,650.00, plus \$100.00 operational fee

- Has at least 50 members.
- Operates a Private Cigar Shop which includes:
  - O A kitchen with a two-burner hot plate, air fryer, or microwave oven;
  - o A sink with hot and cold running water;
  - A 17 cubic foot refrigerator or freezer, or some combination of a refrigerator and freezer which is not used for alcohol storage;
  - o Kitchen utensils and other food consumption apparatus as determined by the commissioner.
- Food fit for human consumption available to be served during all hours of operation on the licensed premises. May utilize a private caterer for limited food menu.
- Maintains, at any one time, not less than a food inventory capable of being prepared in the private cigar shop's kitchen or has on hand at least \$150 in food provided by a private caterer. The commissioner shall include television dinners, bags of chips or similar products, microwaveable food or meals, frozen meals, pre-packaged foods, or canned prepared foods as food inventory.
- Uses an age verification system approved by the commissioner for the purpose of verifying that persons under the age of 21
  who are in the private cigar shop are accompanied by a parent or legal guardian, and if a person under 21 years of age is not
  accompanied by a parent or legal guardian, that person may not be admitted as a guest.
- Meets and is subject to all other applicable private club requirements.

### Requirements ---- Private Bakery - \$650.00, plus \$100.00 operational fee

- Has at least 50 members.
- Operates a bakery which includes
  - O A baking oven and a four-burner range or hot plate;
  - A sink with hot and cold running water;
  - A 17 cubic foot refrigerator or freezer, or some combination of a refrigerator and freezer which is not used for alcohol cold storage;
  - Baking utensils and pans; kitchen utensils, and other food consumption apparatus as determined by the commissioner,
  - o Food fit for human consumption is available to be served during all hours of operation on the licensed premises.
- May sell baked goods infused with liquor, wine, or nonintoxicating beer or nonintoxicating craft beer, either:
  - In the icing, syrup, drizzle or some other topping;
  - O As an infusion where the alcohol is not processed or cooked out of the baked goods; or
  - o The alcohol can be added by the purchaser from an infusion packet containing alcohol no greater than 10 milliliters (by way of a 10-milliliter food grade cupcake pipette).
  - Licensee may sell the baked goods with alcohol added as authorized for on and off premises consumption.
- The licensee may not sell liquor, wine, or nonintoxicating beer or nonintoxicating craft beer for on or off-premises consumption.
- Maintains, at any one time, a food inventory capable of being prepared in the private bakery's kitchen. In calculating the food
  inventory, the commissioner shall include television dinners, bags of chips or similar products, microwavable food or meals,
  frozen meals, pre- packaged foods, baking items such as flour, sugar, icing, and other confectionary items, or canned prepared
  foods.
- Uses an age verification system approved by the commissioner for the purpose of verifying that persons under the age of 21 who are in the private bakery are not sold items containing alcoholic liquors, nonintoxicating beer or nonintoxicating craft beer, or wine, and a person under 21 years of age may enter the shop and purchase other items not containing alcoholic liquors; and
- Meets and is subject to all applicable other private club requirements.

### Requirements ---- Private Farmers Market - \$2,150.00, plus \$100.00 operational fee

- 100+ Members
- Have one or more members operating a private club restaurant, full kitchen with ovens, four-burner ranges, a
  refrigerator, or freezer (or combination of the two), and other kitchen utensils and apparatus as determined by the
  commissioner on the licensed premises and serves freshly prepared food at least 15 hours per week;
- Have one or more members operating who maintain fresh food inventory capable of being prepared for events conducted
  at the private farmers market in the private club restaurant's full kitchen. The food inventory may not include television
  dinners, bags of chips or similar products, microwavable meals, frozen meals, prepackaged foods, or canned prepared
  foods:
- Have an association that owns or leases, controls, operates, and uses acreage amounting to more than <u>1 acre</u>, which is
  contiguous acreage of bounded or fenced real property which would be listed on the licensee's floorplan and would be
  used for large contracted for reserved weddings, reserved dinners, pairing events, tasting events, reunions, conferences,
  meetings, or other special events;
- Have an association that lists in the application for licensure the entire property and all adjoining buildings and structures
  on the private farmers market's floorplan which would comprise the licensed premises, which would be authorized for
  the lawful sales, service, and consumption of alcoholic liquors and nonintoxicating beer or nonintoxicating craft beer
  throughout the licensed premises whether these activities were conducted in a building or structure or outdoors while on
  the private farmers market's licensed premises.
- Have at least 2 separate and unrelated vendors applying for a private farmers market license;
- Only use its employees, independent contractors, or volunteers to purchase, sell, furnish, or serve liquor, wine, nonintoxicating beer, or nonintoxicating craft beer;
- Provide adequate restroom facilities, whether permanent or portable, to serve the stated members and guests who will be attending the private farmers market;
- Provide a copy of a written agreement between all the vendors of the association stating, among other things, that each
  vendor is liable and responsible for all sales, service, furnishing, tendering, and consumption of alcoholic liquors,
  nonintoxicating beer, nonintoxicating craft beer, wine, and cider occurring on the entire licensed premises of the private
  farmer's market;
- Provide a security plan indicating all vendor points of service, entrances, and exits in order to verify members, patrons, and guests ages, whether a member, patron, or guest is intoxicated and to provide for the public health and safety of members, patrons, and guests;
- Use an age verification system approved by the commissioner; and
- Meet and be subject to all other private club requirements.

### Requirements --- Self-pour automated system - \$0 (Must hold a private club type license)

- A private club type may apply to the WVABCA to operate an approved self-pour automated system.
- All self-pour automated system equipment specifications must be submitted to the WVABCA for prior approval. The WVABCA will approve the system or reply back to the licensee submitting the system for approval, with any issues that the WVABCA has found that would prevent the system's approval.
- The self-pour automated system must account for the price differential and ounce differential between and among various nonintoxicating beer, hard cider, or wine being self-poured. If the system is unable to calculate the difference for wine, then a separate card may be used for wine self-pouring.
- Patrons must be verified to be 21 years of age or older prior to being issued a self-pour automated payment card. The licensee or the licensee's employee must verify the patron's age.
- A self-pour automated system may only dispense a pre-paid serving of up to (32 ounces) of non-intoxicating beer before the
  payment card is reactivated and only after the person has been re-verified to be 21 years of age and matches the name on the
  payment card.
- A self-pour automated system may only dispense a pre-paid serving of up to (32 ounces) of hard cider before the payment card is reactivated and only after the person has been re-verified to be 21 years of age and matches the name on the payment card.
- A self-pour automated system may only dispense a pre-paid serving of up to (10 ounces) of wine before the payment card is
  reactivated and only after the person has been re-verified to be 21 years of age and matches the name on the payment card.
- Verification of age must be recorded by the licensee or the licensee's employee in a logbook or in some electronic record retention system for each payment card holder.
- The licensee or the licensee's employee must verify that patrons are not visibly or noticeably intoxicated prior to the issuance of a self-pour automated system payment card and/or prior to use after re-entry of a patron to a licensed premises, if the patron has left.

### **INSTRUCTIONS**

<u>All</u> questions and/or descriptions must be answered. The application <u>must</u> be signed and notarized. If any questions/description cannot be completed in the available space on the application, please submit additional pages as needed. Each additional page submitted must include entity name, DBA name, and indicate which question applicant is answering.

Applications must be completed correctly, and all necessary paperwork included when mailed to the WVABCA. Failure to do so will result in the application being delayed and/or returned to the applicant for the necessary corrections.

LEASE – Applicants must provide a copy of a valid lease if not the property owner.

LICENSE FEES – License fees <u>must</u> be paid by Certified Check, Cashier's Check, Business Check, Personal Check, Credit Card, or Money Order. Cash <u>will not</u> be accepted. Make checks payable to the WVABCA.

All retail licenses are valid from issue date to June 30<sup>th</sup> of the current licensing period. If applying for a license to be issued after December 31<sup>st</sup>, most license fees are semi-annually prorated to half the initial fee.

LIVE SCAN FINGERPRINTING – All applicants must complete a Live Scan Fingerprint in order to obtain a valid license. IdentoGO by MorphoTrust will provide fingerprinting services for all WVABCA license applicants. Contact IdentoGo at 855-766-7746 or online at https://uenroll.identogo.com for information on fingerprinting, locations, scheduling appointments, and fee requirements.

Fingerprint result reports MUST be sent to WVABCA directly from IdentoGo by Morpho Trust.

Please contact the WVABCA Licensing Department at 304-356-5500 to obtain the proper service code for the Live Scan Fingerprinting process.

#### NO REPORTS WILL BE ACCEPTED DIRECTLY FROM LICENSE APPLICANTS.

BONDS – Applicants must have a \$1,000.00 <u>Nonintoxicating Beer Bond</u> and/or a \$5,000.00 <u>Alcohol Beverage Control Bond</u> completed on the form(s) provided by the WVABCA.

HEALTH PERMIT – Applicants must provide a copy of a valid <u>Health Permit</u> issued in applicant's name. <u>(If Association, Limited Liability Company, or Corporation, the Health Permit must be issued in the business entity name and list the DBA name.)</u>

WV SECRETARY OF STATE – All Associations, Corporations, Limited Liability Companies, Non-Profit Clubs, and Fraternal Organizations must be duly certified and registered with the WV Secretary of State.

### INSTRUCTIONS FOR SIGNING:

- a) If an individual, by the owner.
- b) If a partnership, by each member of the partnership (Copy of Partnership Agreement to be submitted to WVABCA).
- c) If an association, by each member of the governing board.
- d) If a corporation, by all officers, or by other persons specifically authorized by corporate resolution (copy of resolution must be enclosed).
- e) If a limited liability company, by all members.
- f) Manager(s) must sign.

All applicants must apply for a "Special Occupation Tax (TTB F 5630.5d)" with the Alcohol and Tobacco Tax and Trade Bureau. Form and instructions are available through download at the following website: <a href="http://www.ttb.gov/forms/f56305d.pdf">http://www.ttb.gov/forms/f56305d.pdf</a> or by calling the toll-free number at 1-800-937-8864. A copy of the TTB form must be submitted with application to the WVABCA.

### **BUSINESS CLOSURE**

If issued, the license may not be abandoned, rented, leased, given, loaned, or sold to another. Upon <u>sale</u> or <u>closure</u> of the applicant's business, the license <u>must</u> be returned to the WVABCA Licensing Division. Please include reason for closure, date business closed, and signature on back of license.
