INSTRUCTIONS FOR COMPLETING APPLICATION FOR RETAIL LICENSE-ON PREMISES PRIVATE HOTEL, PRIVATE RESORT HOTEL, PRIVATE GOLF CLUB & PRIVATE GOLF COURSE

Requirements ---- Private Hotel - \$2,150.00, plus \$100.00 operational fee

- Has at least 2,000 members.
- Offers short-term daily-rate accommodations or lodging for members and their guests of at least 30 separate bedrooms.
- Maintains, at any one time, fresh food inventory capable of being prepared in the private hotel's kitchen. Such food inventory does not
 include microwavable, frozen or canned foods
- Owns or leases, controls, operates and uses 1 acre but fewer than 3 acres, which are all contiguous acres of bounded or fenced real property which would be listed on the licensees' floorplan and would be used for destination hotel and large contracted for group-type events such as weddings, reunions, conferences, meetings, and sporting or recreational eventsOperates a restaurant and full kitchen with ovens, <u>four-burner ranges</u>, walk-in freezers and other kitchen utensils and apparatus, as determined by the commissioner, on the licensed premises and serves freshly prepared food at least 20 hours per week
- Lists the entire property and all adjoining buildings and structures on the private hotel's floorplan which would comprise the licensed premises, which would be authorized for the lawful sales, service and consumption of alcoholic liquors and nonintoxicating beer throughout the licensed premises whether these activities were conducted in a building, structure or outdoors while on the private hotel's licensed premises and as noted on the private hotel's floorplan
- Has an identified person, persons or entity that has right, title and ownership or lease interest in the real property buildings and structures located on the proposed licensed premises
- Utilizes an age verification system approved by the commissioner for persons under the age of 18
- Meets and is subject to all other Private Club requirements.

Requirements ---- Private Resort Hotel - \$7,650.00 - \$22,150.00, plus \$100.00 operational fee

- Has at least 5,000 members.
- Offers short-term daily-rate accommodations or lodging for members and their guests of at least 50 separate bedrooms.
- Operates a restaurant and full kitchen with ovens, <u>six-burner ranges</u>, walk-in freezers and other kitchen utensils and apparatus, as determined by the commissioner, on the licensed premises and serves freshly prepared food at least 25 hours per week.
- Maintains at any one time, fresh food capable of being prepared in the private hotel's kitchen. Such food inventory does not include microwavable, frozen or canned foods.
- Owns or leases, controls, operates and uses acreage amounting to 10 or more contiguous acres of bounded or fenced real property which would be listed on the licensees' floorplan and would be used for destination, resort and large contracted for group-type events such as weddings, reunions, conferences, meetings and sporting or recreational events.
- Lists the entire property and all adjoining buildings and structures on the private resort hotel's floorplan which would comprise the licensed premises, which would be authorized for the lawful sales, service and consumption of alcoholic liquors throughout the licensed premises whether these activities were conducted in a building, structure or outdoors while on the private resort hotel's licensed premises and as noted on the private resort hotel's floorplan.
- Has an identified person, persons or entity that has right, title and ownership or lease interest in the real property buildings and structures located on the proposed licensed premises.
- Utilizes an age verification system approved by the commissioner for persons under the age of 18.
- Meets and is subject to all other Private Club requirement.

Requirements — Private Golf Club (18 hole) - \$2,150.00, plus \$100.00 operational fee

- Has at least 100 members.
- Maintains at least one 18-hole golf course with separate and distinct golf playing holes, not re-using 9 golf playing holes to compromise the eighteen golf playing holes, and a clubhouse.
- Operates a restaurant and full kitchen with ovens, as determined by the commissioner, on the licensed premises and serves freshly prepared food at least 15 hours per week.
- Owns or leases, controls, operates and uses acreage amounting to 80 contiguous acres of bound or fenced real property which would be listed on the private golf club's floorplan and could be used for golfing events and large contracted group-type events such as weddings, reunions, conferences, meetings and sporting or recreational events. Lists the entire property and all adjoining building and structures on the private golf club's floorplan which would comprise the licensed premises, which would be authorized for the lawful sales, service and consumption of alcoholic liquors throughout the licensed premises whether these activities were conducted, in a building, structure or outdoors while on the private golf club's licensed premises and as noted on the private golf club's floorplan.
- Has an identified person, persons or entity that has right, title and ownership interest in the real property buildings and structures located on the proposed licensed premises.
- Utilizes an age verification system approved by the commissioner for persons under the age of 18.
- Meets and is subject to all other Private Club requirements.

Requirements — Private Golf Course (9 hole) - \$2,150.00, plus \$100.00 operational fee

- Has at least 50 members.
- Maintains at least one 9-hole golf course with separate and distinct golf playing holes.
- Operates a restaurant and full kitchen with ovens, as determined by the commissioner, on the licensed premises and serves freshly prepared food at least 15 hours per week.
- Owns or leases, controls, operates and uses acreage amounting to 30 contiguous acres of bound or fenced real property which would be listed on the private golf course floorplan and could be used for golfing events and large contracted for group-type events such as weddings, reunions, conferences, meetings and sporting or recreational events. Lists the entire property and all adjoining building and structures on the private golf course's floorplan which would comprise the licensed premises, which would be authorized for the lawful sales, service and consumption of alcoholic liquors throughout the licensed premises whether these activities were conducted, in a building, structure or outdoors while on the private golf course's licensed premises and as noted on the private golf course's floorplan.
- Has identified person, persons or entity that has right, title and ownership interest in the real property buildings and structures located on the proposed licensed premises.
- Utilizes an age verification system approved by the commissioner for persons under the age of 18.
- Meets and is subject to all other Private Club requirements.

Requirements --- Self-pour automated system - \$0 (Must hold a private club type license)

- A private club type may apply to the WVABCA to operate an approved self-pour automated system. All self-pour automated system equipment specifications must be submitted to the WVABCA for prior approval. The WVABCA will approve the system or reply back to the licensee submitting the system for approval, with any issues that the WVABCA has found that would prevent the system's approval.
- The self-pour automated system must account for the price differential and ounce differential between and among various nonintoxicating beer, hard cider, or wine being self-poured. If the system is unable to calculate the difference for wine, then a separate card may be used for wine self-pouring.
- Patrons must be verified as 21 years of age or older prior to being issued a self-pour automated payment card. The licensee or the licensee's employee must verify the patron's age.
- A self-pour automated system may only dispense a pre-paid serving of up to (32 ounces) of non-intoxicating beer before the payment card is reactivated and only after the person has been re-verified to be 21 years of age and matches the name on the payment card. A self-pour automated system may only dispense a pre-paid serving of up to (32 ounces) of hard cider before the payment card is reactivated and only after the person has been re-verified to be 21 years of age and matches the name on the payment card.
- A self-pour automated system may only dispense a pre-paid serving of up to (10 ounces) of wine before the payment card is reactivated and only after the person has been re-verified to be 21 years of age and matches the name on the payment card.
- Verification of age must be recorded by the licensee or the licensee's employee in a logbook or in some electronic record retention system for each payment card holder.
- The licensee or the licensee's employee must verify that patrons are not visibly or noticeably intoxicated prior to the issuance of a self-pour automated system payment card and/or prior to use after re-entry of a patron to a licensed premises, if the patron has left.

INSTRUCTIONS

- All questions and/or descriptions must be answered. The application <u>must</u> be signed and notarized. If any questions/description cannot be completed in the available space on the application, please submit additional pages as needed. Each additional page submitted must include entity name, DBA name, and indicate which question applicant is answering.
- Applications must be completed correctly, and all necessary paperwork included when mailed to the WVABCA. Failure to
 do so will result in the application being delayed and/or returned to the applicant for the necessary corrections.
- <u>LEASE</u> Applicants must provide a copy of a valid lease if not the property owner.
- <u>Deed and/or Survey Plat</u> Must depicted acreage amounts.
- <u>LICENSE FEES</u>— License fees <u>must</u> be paid by <u>Certified Check, Cashier's Check, Business Check, Personal Check, Credit Card, or Money Order. Cash will not be accepted. Make checks payable to the WVABCA.</u>
- All retail licenses are valid from issue date to June 30th of the current licensing period. If applying for a license to be issued after December 31st, most license fees are semiannually prorated to half the initial fee.
- <u>LIVE SCAN FINGERPRINTING</u>—All applicant(s) must complete a Live Scan Fingerprint in order to obtain a valid license. IdentoGO by Morpho Trust will provide fingerprinting services for all WVABCA license applicants. Contact IdentoGO at 855-766-7746 or online at Llenrollment.com for information on fingerprinting, locations, scheduling appointments, and fee requirements. Please note due to federal requirements Live Scan Fingerprinting must be performed by all license applicants. Please contact the WVABCA Licensing Department at 304-356-5500 to obtain the proper service code for the Live Scan Fingerprinting process.
- Fingerprint result reports MUST be sent to the WVABCA directly from Morpho Trust (L-1). NO REPORTS WILL BE ACCEPTED DIRECTLY FROM LICENSE APPLICANTS.
- <u>BONDS</u> Applicants must have a \$1,000.00 <u>Nonintoxicating Beer Bond</u> and a \$5,000.00 <u>Alcohol Beverage Control Bond</u> completed on the form(s) provided by the WVABCA.
- <u>HEALTH PERMIT</u> Applicants must provide a copy of a valid <u>Health Permit</u> issued in applicant's name for the entire proposed premises. (If an Association, Limited Liability Company, or Corporation, the Health Permit must be issued in the <u>business entity name and list the DBA name.)</u>
- <u>WV SECRETARY OF STATE</u> All Associations, Corporations and Limited Liability Companies must be duly certified and registered with the WV Secretary of State.

INSTRUCTIONS FOR SIGNING:

- a) If an Association, by each member of the governing board.
- b) If a Corporation, by <u>all</u> officers, or by other persons specifically authorized by corporate resolution (copy of resolution must be enclosed).
- c) If a Limited Liability Company, by **all** members.
- d) Manager(s) <u>must</u> sign- a manager should be listed unless owners will be day to day manager.

• All applicants must apply for a "Special Occupation Tax (TTB F 5630.5d)" with the Alcohol and Tobacco Tax and Trade Bureau. Form and instructions are available through download at the following website: http://www.ttb.gov/forms/f56305d.pdf or by calling the toll-free number at 1-800-937-8864. A copy of the TTB form must be submitted with application to the WVABCA.

BUSINESS CLOSURE

The license may not be abandoned, rented, leased, given, loaned, or sold to another. Upon <u>sale</u> or <u>closure</u> of the applicant's business, the license <u>must</u> be returned to the WVABCA Licensing Department. Please include reason for closure, date business closed, and signature on back of license.
